MINISTRY OF LABOUR UPDATES

BRAMPTON, ON, Aug. 30 /CNW/ - Premier Candle Corp., a candle manufacturer based in Mississauga, Ont., was fined \$105,000 on August 28, 2007 for two violations of the Occupational Health and Safety Act that resulted in serious burns to a worker. On October 3, 2005, a driver was delivering hot liquid wax in a truck to Premier Candle Corp. when the driver's upper body was sprayed with the wax. At the time of the incident the driver had just finished filling a silo with wax and was detaching pipes through which the wax had been transferred. The driver suffered second and third degree burns to the right side, including to the arm, chest, stomach and knee.

The company did not notify the Ministry of Labour of the incident, but the ministry learned about it two days later from a third party. When the ministry arrived at the scene, it was not taped off and all mobile equipment had been removed. The only evidence of the incident was solidified wax markings in the silo area at the company's plant at 960 Britannia Road in Mississauga. The injured worker was employed by Gary Jackson Trucking Inc. of Oakville, Ont., which had been contracted by Premier Candle Corp. to deliver the wax.

A Ministry of Labour investigation found the driver was unfamiliar with the silo equipment and was not given any supervision or instructions by Premier Candle Corp. on how to load the wax into the silo. There was no verbal or written information or instruction on a safe procedure for the delivery of the hot wax from the truck to the silo. There were also no identifying marks on the silo valve or attachments indicating the open and closed positions and no wax flow direction identified on the silo valves, fitting and piping.

Premier Candle Corp. pleaded guilty, as an employer, to:

- 1. Failing to provide the driver with information, instruction and supervision on the safe loading of the hot liquid wax from the truck into the silo. This was contrary to Section 25(2)(a) of the act; and
- 2. failing to report the injury incident to the Ministry of Labour, as required by Section 51(1) of the act.

Justice of the Peace John Farnum of the Ontario Court of Justice in Brampton, fined the company \$80,000 on the first count and \$25,000 on the second count. In addition to the fines, the court imposed a 25-per-cent victim fine surcharge, as required by the Provincial Offences Act.

The Occupational Health and Safety Act requires that most workplaces with 20 or more workers have at least one worker and one management person to serve as certified members of a workplace Joint Health and Safety Committee (JHSC). This certification involves training in health and safety law, and the identification, assessment and control of hazards.

Certification involves two mandatory parts: Basic Certification and Workplace-Specific Hazard Training:

Part One - Basic Certification provides an overall knowledge of health and safety that applies to all workplaces.

Part Two - Workplace-Specific Hazard Training focuses on significant hazards in your workplace. It covers how to assess those hazards and ways to control and/or eliminate them.

One worker and one management designated JHSC member must complete both Part One and Part Two of the Training.

TWO MEN DIE IN UNDERGROUND TRAGEDY

Two men working underground on telecommunications wiring have died in a workplace tragedy.

On June 28th, 2007 shortly before 10:30 a.m., two men, employees of Wesbell Technologies in Mississauga were working on telecommunications wiring in the area of Third Line and North Service Road in Oakville. Both men were underground when for as yet undetermined reasons they began to have difficulty.

A co-worker came upon them and realized they were in danger. That co-worker contacted emergency services.

The Halton Regional Police Service, Oakville Fire Department and Halton Emergency Medical Services responded. Oakville Fire Department's Rope Rescue Unit successfully removed the men.

Upon reaching the surface, they along with Halton EMS began life saving measures. Both men were found to be vital signs absent. The men were taken by land ambulance to the Oakville Trafalgar Memorial Hospital where they were later pronounced deceased.

The men are identified as a thirty three year old man from Brampton who had worked in the industry for approximately fifteen years and a fifty two year old man from Binbrook who has worked in the industry for approximately thirty two years.

Investigators from the Halton Regional Police Service and Human Resources Development Canada Labour Program are working to identify the cause. The investigation is expected to take some time as air quality tests have shown a risk to investigators exists below the surface.

Human Resources Development Canada Labour Program investigators are in charge of the investigation.
