SAFETY MANAGERS: <u>NEW OH&S ENFORCEMENT TARGETS?</u> By: Cheryl A. Edwards and Nadia Pazzano

Historically, safety managers have flown under the radar when decisions respecting OH&S prosecution after a workplace accident are made. Normally prosecution and potential liability is seen as limited to those who have explicit duties for ensuring the safety of workers under the legislation: employers, constructors, supervisors, workers, and a few other parties.

R v. Bernard Richard (Dick) Dearing, a recent Nova Scotia OH&S prosecution, represents a historic departure from this norm. On May 8, 2007, Mr. Dearing pled guilty, in his personal capacity as "safety manager", to failing to establish and maintain a health and safety program in consultation with the joint health and safety committee. This Update comments on the case and discusses ways to offset the risk of health and safety managers being seen as potential new targets for OH&S enforcement.

MINISTRY OF LABOUR UPDATES

SCARBOROUGH - The Board of Governors of Exhibition Place, a local board of the City of Toronto that oversees Exhibition Place, was fined \$100,000 on September 10, 2007 for a violation of the Occupational Health and Safety Act that resulted in serious burn injuries to two employees. On August 17, 2005, two electrical workers were investigating the source of a partial power loss to a concession stand when there was an electrical explosion and the workers' clothing caught on fire. Fire extinguishers were used to put out the fire. Both workers suffered second and third degree burns. At the time of the incident one of the workers had been using a screwdriver trying to pry a fuse from a switch terminal. The incident occurred at an electrical substation at Exhibition Place at the Canadian National Exhibition (CNE) grounds in downtown Toronto.

A Ministry of Labour investigation found the worker who was using the screwdriver had turned an external switch door handle to the "off" position, but the internal switch mechanism was still in the "on" position. There was a live electrical path at the switch terminal resulting in the explosion when the screwdriver contacted the fuse. Neither of the workers had been provided with, or were wearing any, personal protective equipment. The Board of Governors of Exhibition Place pleaded guilty, as an employer, to failing to take the reasonable precaution of ensuring the two workers were provided with personal protective equipment to protect them from the hazard of electrical shock and burn. This was contrary to Section 25(2)(h) of the act.

KITCHENER - Process Group Inc., a Cambridge-based supplier of engineering, procurement, construction, and maintenance services to manufacturing plants, process equipment vendors, engineering firms and industrial design builders, pleaded guilty in the Ontario Court of Justice on September 11, 2007, and was fined \$90,000 in relation to an incident that injured a worker in 2005. Process Group Inc., contracted with Gerdau Ameristeel Corporation to perform maintenance work at the Gerdau plant. On May 21, 2005, a Process Group Inc., employee fell more than 4.5 metres through an opening at the side of a work platform resulting in spinal injuries and paralysis. Process Group Inc., pleaded guilty, as an employer, to failing to ensure the worker was wearing a serviceable safety belt or harness to prevent a fall of more than three metres, as required by section 85 of Ontario Regulation 851, contrary to paragraph 25(1)(c) of the Occupational Health and Safety Act.
